I. Organics Project Update

Dave Aldridge informed us that we will be able to utilize a 3-phase generator owned by New London to supply electricity to the test site. We are waiting for Brian Sear's approval and if given, to test the noise the generator makes. If not available or not suitable we are costing out running phase 1 power to the site to be converted to 3 phases at the site. Mr. Aldridge has had discussions with Blue Earth Compost who said they could supply the necessary 30 tons of food scrap. Yesterday, Mr. Aldridge re-toured the WWP site with John and Winston, and we are still pursuing two potential sites in North Stonington. He has also begun discussions with a company in Plainfield, East Coast Materials Management, who may be both an alternative for shipping wood mulch and have an interest in our finished compost should we be successful in developing a facility. They have a 38-acre facility where they bag and mulch soil products.
