#### II. Year-end Financial results

Mr. Aldridge went over the year end financial report. SCRRRA's total net loss for Year End FY 2022 is \$3,136,000 which is even with plan. Before interest & dividend income we were \$268,000 or 5% better than plan. Revenue was \$7,903,000 which nis 2% better than plan. MSW expense was up \$1,900 or even with plan, recycling was \$237,000 or 18% under plan, note: the mid contract adjustment was added in at the Casella rate of \$29.39 which provided \$88,000 in revenue. Operating accounts significantly under plan were Administration \$37,000, and Landfill expense \$40,000. Accounts over plan were HHW \$41,000, Compost Test \$20,000, Service and Maintenance \$37,000, Fuel \$37,000, and Mulch Hauling \$64,000.

MSW tonnage was up 2,819 tons or 2%, recycling down 615 or 3% under plan. We have submitted the FY 2022 records to our Auditing firm to begin working on our year-end audit, a draft of which should be prepared by our December Board Meeting.

#### **III.Year-End Operational Results**

Mr. Aldridge referred to the paperwork package where there is a recap of each town and the SCRRRA total for FY 2022. We had issues with the HHW tabulation and will post the final version to our Town Web Portal when complete. We will also post the trailing two years so you can analyze trends.

#### **IV.Standing Committees**

Mr. Aldridge stated that the coming years will present numerous challenges, some of them existential. He is recommending this structure as a way to ensure we meet those challenges in the best way possible.

#### **IV.Mixed Recycling Contamination**

Mr. Aldridge informed us that on August 24<sup>th</sup> he spent the morning at Casella and watched their process for auditing inbound loads for Trash Residue. They had two loads that they had isolated, one from the Montville Transfer Station, one curbside pickup from Norwich. The Willimantic Facility has three inspectors assigned to auditing, they plan to audit 10-12 loads per day. For the last 3 weeks they have only audited SCRRRA loads in order to create a beginning database of information that we can use. Additionally, he met Devon Spector, Casella's Environmental Manager, who is responsible for their DEEP compliance for inbound auditing and notifying municipalities of loads over 2% contamination. He offered to help us in our efforts and promised to send examples of media that they have used successfully in other campaigns.
