## I. Organics Update

#### USDA Grant

### II. Employee 2025 Health Care Selection

We reached out to our broker regarding possibility of getting the same policy identical to last year. This plan no longer exists, and they migrated us to the \$7,500 deductible plan. For a group the size of SCRRRA, the choices are limited.
